



DISNEY NOW MORE THAN EVER CONTEST RULES

These rules apply to DISNEY NOW MORE THAN EVER Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WROR (“Station”). **In addition, the General Contest Rules posted at www.wror.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on March 3, 2019 and end on March 15, 2019.
- b. To enter on-air, listen to the Station beginning on Friday, March 8, 2019 at 6:00am Eastern Time (“ET”) and ending on Sunday, March 10, 2019 at 6:00pm ET for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced on-air at the time of the cue to call) to the Station contest line at 617-931-1057 will win an On-Air Qualifying Prize and be qualified for a chance to win the Grand Prize (each deemed a “Qualifier”), upon confirmation of eligibility. Station is not responsible for any failure of a caller to reach the Station contest line including but not limited to busy phone lines, misdirected calls, equipment breakdowns, or disconnections. Calls will only be accepted at the designated phone number. At the time of entrant’s call, entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line and completes the call will be a Qualifier. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a Qualifier only once. **Up to fifteen (15) Qualifiers will be selected on-air. Potential Qualifiers will be notified at the time of their call.**
- c. To enter online, visit www.wror.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on Sunday, March 3, 2019 at 12:00am ET and ending on Friday, March 15, 2019 at 11:59pm ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- d. There will be up to a total of fifteen (15) On-Air Qualifying Prize winners and one (1) Grand Prize winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in MA, NH or RI except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to fifteen (15) On-Air Qualifying Prizes will be awarded. Each On-Air Qualifying Prize consist of a one hundred dollar (\$100.00) Disney Gift Card, valid at select participating locations at Walt Disney World® Resort, Disneyland® Resort, Disney Cruise Line, Disney store locations in the U.S., Canada, and Puerto Rico, shopDisney.com DisneyPhotoPass, Adventures by Disney®, Aulani, A Disney Resort & Spa, and Disney's Beach Resorts. It cannot be used toward the purchase of a Disney Vacation Club Membership. The Approximate Retail Value ("ARV") of each On-Air Qualifying Prize is \$100.00.

The gift card will be subject to the terms and conditions as set forth by the issuer of the gift card. Gift cards are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will gift cards be replaced if lost or stolen.

- b. Up to one (1) Grand Prize will be awarded. The Grand Prize consists of one (1) vacation package for four (4) persons for four (4) nights and five (5) days at the *Walt Disney World*® Resort and consists of the following:
 - Four (4) round trip coach airfares between the major gateway airport closest to traveler's residence and the Orlando International Airport.
 - Four (4) round trip ground transfers between the Orlando International Airport and the *Walt Disney World*® Resort via Disney's Magical Express Service.
 - Room accommodations consisting of one (1) standard room(s) (with a maximum of four (4) persons per room) for four (4) night(s) at a hotel at the *Walt Disney World*® Resort selected by Disney in its sole discretion; based on availability.
 - Four (4) 5-Day Magic Your Way Tickets with Park Hopper® Option.

Items that are not included as part of the winning vacation package(s) are: meals, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, etc., local and long distance telephone calls, tips, gratuities, service charges or taxes. All other charges and items not otherwise described above.

ARV of the Grand Prize is \$6,002.20.

- Vacation(s) must be taken between 3/4/2019 and 12/20/2019.
- Departure date and accommodations are subject to availability; certain restrictions and block-out dates may apply.
- Vacation(s) is/are for the winner(s) of the sweepstakes/contest and three (3) guests of the winner's choosing.
- Vacation(s) and vacation components may not be sold, traded, transferred, rescheduled to dates not within the fulfillment period set forth above, or refunded. Vacation(s) is/are not redeemable for cash.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). Prize or prize certificate must be claimed within thirty (30) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to fifteen (15) On-Air Qualifying Prize winners will be selected and notified on-

air as described above.

- b. Up to one (1) Grand Prize winner will be selected at approximately 10:00am ET on Monday, March 18, 2019 in a Station-conducted random drawing from all combined eligible online entries received during the Online Entry Period and the On-Air Qualifying Prize winners. The potential Grand Prize winner will be notified by phone and must confirm acceptance of prize within twenty-four (24) hours or risk disqualification and selection of a new winner (time permitting) in a random drawing from all remaining eligible entries.
- c. Odds of winning an On-Air Qualifying Prize depend on the number and order of calls received. Odds of winning the Grand Prize depend on the number of eligible online entries received during the Online Entry Period and On-Air Qualifying Prize winners.
- d. Entrants must listen to the Station but need not be present to win an On-Air Qualifying Prize. Entrants and On-Air Qualifying Prize winners need not listen to the Station or be present to win the Grand Prize.
- e. Grand Prize winner must confirm acceptance of prize within three (3) days of winning, or risk disqualification and selection of an alternate Grand Prize winner (time permitting) in a random drawing of all remaining eligible online entries and On-Air Qualifying Prize winners.
