

FREE TICKET FRENZY GIVEAWAY OFFICIAL CONTEST RULES

These rules apply to Free Ticket Frenzy Giveaway Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WROR-FM (“Station”). **In addition, the General Contest Rules posted at wror.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, March 13, 2023 and end on Friday, April 7, 2023.
- b. To enter, listen to the Station each **weekday** beginning on Monday, March 13, 2023 and ending on Friday, April 7, 2023 between the hours of 8:00 PM EST and 5:00 PM EST for the announcement of a unique Contest keyword (“Keyword”). Each announcement will have a unique Keyword. Once an entrant hears the Keyword, entrant may enter via the following method:
 - i. Text the Keyword to 888-410-1057. Message and data rates may be charged by your wireless carrier. The Station is not responsible for any fees incurred by you for this method of entry. Text message and any mobile device entries will be deemed made by the authorized account holder of the mobile account submitted at the time of entry. The authorized account holder is the natural person who is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. By initiating a text message to the Station in this contest, you also expressly consent to the receipt of a reply message confirming your entry and notification via text if you are selected to be a winner.
 - ii. Only one (1) entry per person per Keyword is permitted. Multiple entrants are not permitted to share the same telephone number. Entrants are not permitted to use multiple telephone numbers. The deadline to enter each Keyword is fifteen (15) minutes past the airing of the cue to call. Any text message received after fifteen (15) minutes past the cue to call or any text message with the incorrect Keyword will be disqualified. Up to one (1) winner will be selected for each Keyword announcement as described below in Section 4.
- c. There will be up to a total of sixty (60) Prize winners selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Massachusetts, New Hampshire or Rhode Island, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to sixty (60) prizes will be awarded in this Contest. Each prize consists of a pair of tickets to one of the shows listed below:

 - Peter Gabriel at TD Garden on September 14th, 2023
 - Depeche Mode at TD Garden on October 31st, 2023

- b. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond control of the Station and/or prize provider, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded element(s) of the prize(s). The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior, does not follow Station and/or venue policy regarding COVID-19 guidelines, or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize-related event. Winner understands that there are inherent risks involved in attending the prize-related event.

Prize or prize certificate must be claimed within one (1) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to sixty (60) prize winners will be selected on-air as described above.

Up to three (3) winners will be selected each weekday beginning on Monday, March 13, 2023 and ending on Monday, April 10, 2023 at approximately 10:00am ET in a Station-conducted random drawing from all eligible text message entries received on the previous weekday. Potential winner will be notified by phone promptly following the random drawing.

- b. Odds of winning depend on the number combined text message and online entries received for each random drawing.
- c. Entrants must listen to the Station for the Contest Keywords, but need not be present to win.
- d. Winner must confirm acceptance of prize within ten (10) minutes of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible text message entries from the respective entry pool.
- e. Decisions of Station management with respect to the Contest are final.
